### **Sheriff Greg Champagne Announces the Relocation of Sheriff's Office Divisions due to Closure of the Parish Courthouse on August 9<sup>th</sup> and 10<sup>th</sup>, 2018 by Order of the 29<sup>th</sup> Judicial District Court and Parish President:**

On Thursday August 9<sup>th</sup> through Friday August 10<sup>th</sup>, 2018, the St. Charles Parish Courthouse will undergo necessary scheduled maintenance. This will require the **COMPLETE CLOSURE** of the courthouse to the public and employees who work within the building as ordered by the 29<sup>th</sup> Judicial District Court and Parish President. Any citizen with business on those days should contact the respective parish agencies for more information of services availability. This closure **only** affects the government offices located within the courthouse building itself. The maintenance work will also be performed on Saturday August 11, 2018 and Sunday August 12, 2018 if necessary.

All divisions of The St. Charles Parish Sheriff's Office will be open for business as usual. Those divisions normally housed in the parish courthouse building will be open as well in the following locations:
